- 1. That the school shall abide by the provision of the Delhi School Education Act & Rules,1973 and other instructions of the Separtment issued from time to time
- That the school shall admit the students without any discrimination of daste and creed.
- of That the school shall appoint the staff and within the prescribed age limited and send the list of the employees to the Department for scruting.
- 4. That the school shall strictly shide by the provisions of Delhi School Education Act and Rules,1973 and payment of pay and allowances and other facilities will be made as per section 10(1) of Delhi School Education Act,1973 to all its employees.
- 5. A proper Library with number of books as prescribed by Department will be equipped during 1991-1992 and onward.
- o. The facilities as required under Rule 50 and 51 of Delhi School Education Rules, 1973 shall be made available. Provisions of Rules6, 7& 8 be strictly observed.
- 7. That no unqualified or overaged staff may be allowed to continue.
- 8. That the staff should be paid their salary through crossed chaques.
- 7. That the school shall create a Reserve Fund of Rs.30,000 in the joint name of Manager and DDE (Disti South) immediately.
- 10. That the Managing Committee of the school shall not increase fee in future academic session without prior approval of the Director of Education, Delhi.
- 11. That the service contract between the Management and the employees shall be executed immediately.
- 12. That no unrecognised classes shall run in the school building.



That the school pay arrears and other benefits to the iployees as per recomendation of the Fourth pay Commission.

- 14. That the increment and HRA will be paid to the staff with retrospective effect.
- That the violation of any instruction/condition/rule regulations of the Department shall lead to the withdrawal recognition of school.
- 16. Compliance reports of the conditions may be submitted to the undersigned latest by 1.12.91.

I am directed to convey the approval of the Director of Education.

Delhi for the upgradation of the existing School to School to Section level without aid w.e.f. 1986-89 session subject to the following terms and conditions:-

- 1. That the school shall abide by the provision of DSEA, 1973 and rules framed thereunder as well as the instructions issued from time to time.
- 2. That the school shall meet the additional libility of Secondary classes.
- 3. That the school shall admit the students without any discrimination of caste and creed.
- 4. That a proper library shall be established and facilities for reading room/a hall also be made available for students as well as teachers. Books as per the ratio of 10 books per student shall be purchased and made available to the students.
- 5. That adequate sports material shall be purchased and made available to the students.
- 6. That the school shall strictly abide by the provisions of section 10(1) of DSER, 1973.
- 7. That the school shall not run any unauthorised classes or any other activities within the school premises and all the recognised classes shall be run at one place at the premises of a school.
- 8. That the school shall dispense with the service of uncullified and over-aged staff, if any immediately.
- 9. That the service contract between the Management and the employees be revised as per DSER and Rules, 1973, shall be executed immediately.
- 10. The Management Committee shall regulate the functioning of school strictly in accordance with the provisions of DSER, 1973.
- 11. The Manageog Committee of the school shall not increase Fees

- or Education which is a mandatory requirement under subsection(3) of Jection 17 of Delhi School Education Act & Rules.
- That all the facilities prescribed under rule 50 & 51 of the 12. DSEA and Rules, 1973 shall be made available to the students.
- Proof to the effect that qualified staff including the Principal 13. appointed as per ict & Rules be provided for the verification of the E.O. concerned.
- That the staff has been said all arrears and being paid salary 14. as per fourth pay commission. Proof of the same be given to E.Q. concerned.
- 15. That the arrangement for good drinking water shall be made available to all the students as well as the teachers and sanitary facilities shall also be provided to the students adequately.
- 16. That the school shall comply with the norms of the DSER, 1973 for affiliation for examination purpose.
- Medical facidities/leave, LTC, Bonus, Teaching allowances, Provident 17. rund etc. be paid since recognition of school.
- Provident fund register be maintained and cash book be completed 18. and shown to E.O. of the Zone concerned for verification from EHE time to time.
- 19, That the Management of the school shall create a reserve fund x. in the Form of Fixed Deposit in the joint account in the name of Dy.Director of Education (South West) and the Manager of the school &-equivalent to 3 months salary of the staff.
- That the violation of the instructions/conditions/rules and 20. regulation of the department shall lead to the withdrawal of recognition of the school.
- That in no case the school funds will be diverted/transferred 21. to any other fund/account of the society. The school funds will also not be utilised by the society for any other purpose other than that the school.
- 22. That the report about fulfilment of the above conditions shall be sent to the E.O. concerned every 6 months.
- 23. Salary to the staff should be made through crossed cheque.
- The upgradation town scanding level is allowed in June 1 and Commerce Stream
